AN ORDINANCE AMENDING SECTION 02 OF MUNICIPAL ORDINANCE NO. 07, SERIES OF 2016, KNOWN AS AN ORDINANCE CREATING ADDITIONAL PLANTILLA POSITIONS IN THE LOCAL GOVERNMENT UNIT OF PROSPERIDAD, AGUSAN DEL SUR AND APPROPRIATING FUNDS THEREOF

BE IT ORDAINED by the Sangguniang Bayan of Prosperidad, Agusan del Sur in session assembled that;

SECTION 1. TITLE - This ordinance shall be known as "AN ORDINANCE AMENDING SECTION 02 OF MUNICIPAL ORDINANCE NO. 07, SERIES OF 2016, KNOWN AS AN ORDINANCE CREATING ADDITIONAL PLANTILLA POSITIONS IN THE LOCAL GOVERNMENT UNIT OF PROSPERIDAD, AGUSAN DEL SUR AND APPROPRIATING FUNDS THEREOF".


SECTION 2- AMENDMENT - Section 2 of Municipal Ordinance No. 07, series of 2016 is hereby amended and to now read as follows;

SECTION 4. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon its approval.


