

SECTION 2. AUTHORITY TO RECLASSIFY – Section 20 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of utilization.


SECTION 3. RECLASSIFICATION – The Parcel of land bearing Lot no. 2208-C-4 PSD-13-008474, Area-5.000 hectares; and Lot no. 2208-C-2 PSD-13-008474, Area-2.3587 hectares, located at Purok 28, Poblacion, Prosperidad, Agusan del Sur are hereby re-classified from agricultural to residential land use.

SECTION 4. MANNER OF UTILIZATION – The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of the Municipality of Prosperidad, this province and other applicable laws, rules and regulations.

SECTION 5. CONVERSION – This ordinance shall not be construed as a conversion order which shall be issued by the Department of Agrarian Reform.

SECTION 6. EFFECTIVITY – This ordinance shall take effect upon approval.



AN ORDINANCE RE-CLASSIFYING FROM AGRICULTURAL TO RESIDENTIAL LAND USE, PARCEL OF LANDS BEARING LOT NO. 2208-C-4 PSD-13-008474, AREA-5.000 HECTARES; AND LOT NO. 2208-C-2 PSD-13-008474, AREA-2.3587 HECTARES, ALL LOCATED AT PUROK 28, POBLACION, PROSPERIDAD, AGUSAN DEL SUR

BE IT ORDAINED by the Sangguniang Bayan of Prosperidad, Agusan del Sur in session assembled that:

SECTION 1. TITLE – This Ordinance shall be known as "An ordinance re-classifying from agricultural to residential land use, parcel of lands bearing Lot no. 2208-C-4 PSD-13-008474, Area-5.000 hectares; and Lot no. 2208-C-2 PSD-13-008474, Area-2.3587 hectares, all located at Purok 28, Poblacion, Prosperidad, Agusan del Sur"
